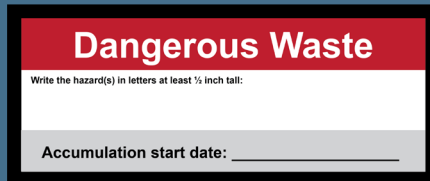


# WHAT ARE THE LABELING REQUIREMENTS?

## BASIC LABELING REQUIREMENTS

- ◇ The words "dangerous waste" or "hazardous waste"
- ◇ Showing all hazards and their nature
- ◇ Accumulation start dates (except for satellite area containers)

## TEXT-ONLY LABEL REQUIREMENTS



- ◇ You may label entirely with text-only labels. If you do, the lettering may have a size or visibility requirement depending on the container size.

## PICTOGRAM LABEL REQUIREMENTS

- ◇ Hazard labels can also be pictograms (pictures) that may or may not include text. If you choose to display a hazard label that uses a pictogram, make sure the label is clearly recognizable.

## Hazardous Waste

## BEST MANAGEMENT PRACTICES (BMPs)

## LARGE CONTAINERS

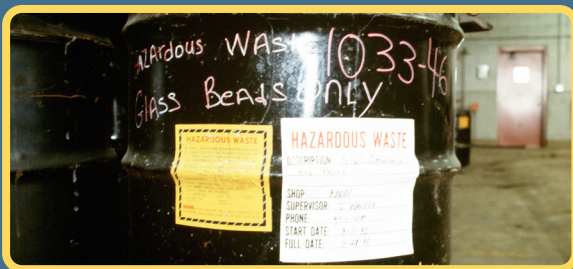
(Greater than 1 gal or 4 L)

- ◇ "Hazardous waste" or "Dangerous waste" legible from 25 feet or lettering at least 0.5 inches high
- ◇ Hazard labels (with pictograms) recognizable from 25 feet, or (text-only) legible from 25 feet or lettering at least 0.5 inches high
- ◇ The accumulation date has no size requirement

## SMALL CONTAINERS

(Less than or equal to 1 gal or 4 L)

- ◇ "Hazardous waste" or "Dangerous waste" legible from 25 feet
- ◇ Hazard labels (with pictograms) or (text-only) sized appropriately for the container
- ◇ The accumulation date has no size requirement



## TANKS

(Labels by category)

### MEDIUM QUANTITY GENERATORS

- ◇ "Hazardous waste" or "Dangerous waste" legible from 25 feet
- ◇ Hazard labels (with pictograms) recognizable from 25 feet, or (text only) legible from 25 feet
- ◇ Accumulation start date has no size requirement



### LARGE QUANTITY GENERATORS

- ◇ "Hazardous waste" or "Dangerous waste" legible from 50 feet
- ◇ Hazard labels (with pictograms) recognizable from 50 feet or (text only) legible from 50 feet
- ◇ Accumulation start date has no size requirement



## PICTOGRAMS FOR COMMON HAZARDS



### Health Hazard

- ◇ Carcinogen
- ◇ Respiratory Sensitizer
- ◇ Reproductive Toxicity
- ◇ Target Organ Toxicity
- ◇ Mutagenicity
- ◇ Aspiration Toxicity



### Exclamation Point

- ◇ Irritant
- ◇ Dermal Sensitizer
- ◇ Acute Toxicity
- ◇ Narcotic Effects
- ◇ Respiratory Tract Irritation



### Flame

- ◇ Flammables
- ◇ Self Reactives
- ◇ Pyrophonics
- ◇ Self-Heating
- ◇ Emits Flammable Gas
- ◇ Organic Peroxides



### Exploding Bomb

- ◇ Explosives
- ◇ Self Reactives
- ◇ Organic Peroxides



### Flame Over Circle

- ◇ Oxidizers

- ◇ Aquatic Toxicity



### Skull & Crossbones

- ◇ Acute Toxicity
